QUALIFICATION

The requisite eligibility/qualifications is as under:-

- (i). The candidate shall possess a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized University
- (ii) The candidate shall have to pass a test at a speed of 80 W.P.M. in English Shorthand and 20 W.P.M. in Transcription of the same on computer and shall have proficiency in computers (Word Processing and Spread sheets).

AGE LIMIT

No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 1.1.2024. Upper age limit is relaxable as per instructions of the Hon'ble High Court and as prescribed by the Haryana Government from time to time.
